

# Scatec South Africa's Privacy Policy

The Protection of Personal Information Act, 2013 (POPI Act) regulates the processing of personal information of data subjects by responsible parties in a manner that gives effect to this right, subject to limitations. The processing of personal information is therefore limited but not prohibited. Scatec takes data privacy seriously however all data subject requests will be handled on a case-by-case basis.

The POPI Act, provides citizens with enforceable rights over their Personal Information. The right to privacy is an integral human right recognised and protected in the Constitution of the Republic of South Africa and given regulatory effect in the legislative requirements under the POPI Act. The POPI Act aims to promote the protection of privacy through providing guiding principles that are intended to be applied to the processing of Personal Information in a context-sensitive manner.

### Scatec's PAIA Manual

The Promotion of Access to Information Act 2 of 2000 (PAIA) gave effect to section 32 of the Constitution of the Republic of South Africa, which provides that everyone has a right of access to information held by a public or private body, that is required for the exercise or protection of any rights.

Refer to the Scatec Information Manual in the link below to access the "Information Manual of South African Based Subsidiaries - PAIA Manual." The PAIA Manual is published in terms of Section 51 of the Act. PAIA sets out the requirements which a requester for such information must meet as well as the grounds upon which the request can be refused. The PAIA Manual informs Scatec requesters on the procedural steps to be taken to gain access to such information.

The request is subject to the limitation under PAIA, which recognises that such a right of access to information is subject to justifiable limitations that can be exercised by Scatec.
